## **Extended Active Membership – Defined**

Presented to the Rotary Club of Owatonna members at the January 28, 2013, Club business meeting. Todd Hale moved, and Steve Olsen seconded, that the Bylaws change be approved. *The motion passed.*

**Background:** There has long been a desire for the Owatonna Rotary Club to create or modify club by-laws pertaining to membership classifications that would accommodate inclusion of spouses of members, and foreign nationals who visit our club periodically and in whose country of citizenship Rotary Clubs do not exist. The intention of such action would be to 1) provide an affordable means for households to have multiple members belong to the Owatonna Rotary Club, 2) affordably allow qualifying foreign nationals to act as ambassadors for Rotary International and Owatonna Rotary and 3) not burden the Owatonna Rotary Club with unfunded services for members of this classification.

**Recommendation:** That the Owatonna Rotary Club amend its by-laws in order to provide affordable membership for **multiple members of a household and for qualifying foreign nationals**. Such classification of membership shall be known as “**Extended Active Membership**” in which:

1. **spouses** of full dues-paying members of the Owatonna Rotary Club seeking Extended Active Membership shall be required to pay the same dues rate as required of retired active members plus expenses for meals they consume. In the event that the full dues paying member of the household drops his/her membership, the Extended Active Member must choose to become a full dues-paying member (or retired active member – if eligible) or drop membership from the club.
2. **qualifying foreign nationals** seeking Extended Active Membership shall be required to pay the same dues rate as required of retired active members plus expenses for meals they consume. At such time as a Rotary Club becomes accessible to them in the region in which they reside, their Extended Active Membership in the Owatonna Rotary Club shall be revoked and membership in the club in their region be encouraged.
3. Persons seeking the classification of Extended Active Membership who have submitted their application along with their initiation fee and who have been approved by the Board and accepted by the Club shall have the same rights and privileges in the Owatonna Rotary Club, Rotary District 5960 and Rotary International as persons classified as Active Members.
